

ORDINANCE NO. 1235

AN ORDINANCE OF THE CITY OF OVIEDO, FLORIDA, CHANGING THE NAME OF GOPHER TURTLE PLACE AS DESIGNATED ON THE PLAT OF THE SANCTUARY PHASE I IN PLAT BOOK 58, PAGES 28, 36 & 37 AND PHASE II PLAT BOOK 62, PAGES 48, 49, 50, 51 & 54 TO HEIRLOOM ROSE PLACE; PROVIDING FOR SEPARABILITY, CONFLICTS, AND EFFECTIVE DATE.

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA, AS FOLLOWS:

WHEREAS, The City Council of the City of Oviedo, Florida recognizes possible hazard to life or property due to confusion resulting from different street names for connected streets.

WHEREAS, the City Council of the City of Oviedo, Florida, deems it in the best interest of the City and public safety to change the street name of Gopher Turtle Place to Heirloom Rose Place.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA:

Section 1: That the street designated as Gopher Turtle Place on the plat of The Sanctuary, Phase I, Plat Book 58, Pages 28, 36, & 37 and Plat Book 62, Pages 48, 49, 50, 51 & 54 be changed to Heirloom Rose Place.

Section 2: The provisions of this ordinance are declared to be separable and if any section, sentence, clause or phrase of this ordinance shall for any reason be held invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, phrases, or clauses of this ordinance, but they shall remain in effect, it being the legislative intent that this ordinance shall stand notwithstanding the invalidity of any part.

Section 3: All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.

Section 4: This ordinance shall become effective immediately upon adoption.


