WHEREAS, a petition was filed by the City Commission of the City of Altamonte Springs, Florida, to rename that certain right-of-way known as Lake Harriet Drive, lying within the City of Altamonte Springs, Florida, described as being that north-south portion of Lake Harriet Drive from State Road 436 to the point where it meets the east-west direction of Lake Harriet Drive.

WHEREAS, notice of public hearing before the City Commission of the City of Altamonte Springs, Florida, on the 5th day of September, A.D. 2004, was published in the Orlando Sentinel, a newspaper of general circulation in Seminole County, Florida one (1) time at least thirty (30) days prior to the date stated therein for such hearing; said notice was further published by posting same in three (3) public places within the corporate limits of the City of Altamonte Springs, Florida, for a period of at least thirty (30) days prior to the date stated therein for such hearing; and

WHEREAS, a notice of public hearing was sent to affected property owners of the name change at least thirty (30) days prior to the date stated therein for such hearing; and

WHEREAS, the City Commission finds that the renaming of that certain street right-of-way will not operate to the detriment of the City or public. :



4. The resolution shall become effective immediately upon its final passage and adoption.
