

THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING OF JANUARY 25, 2011.

WHEREAS, under the authority contained in Sections 336.05(1) and 336.05(2), Florida Statutes, the Board of County Commissioners may name and rename streets and roads; and

WHEREAS, The Board of County Commissioners has deemed it expedient to rename a segment of Beardall Avenue to North Beardall Avenue and South Beardall Avenue; and

WHEREAS, the segments of Beardall Avenue to be renamed are is wholly located within unincorporated Seminole County; and

WHEREAS, renaming these streets will help to eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, Florida; and

WHEREAS, this change is consistent with overall County plans for street renaming, naming, addressing and the 911 system,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:

Effective January 25, 2011, the street is renamed as follows:

That portion of Beardall Avenue located in Platt of the Town of Canaan, Block 8, Lots 12A, 12 and 1, Block 1, Lots 11 and 1, Plat Book 1, Page 103; Flynt Subdivision, Block D, Lot 5, Plat Book 8, Page 36; Tax Parcel: 14 in Section 4 Township 20, Range 31 and Tax Parcels: 120, 114, 113, 56, 20, 19B, 19A, 18, 17, 13, 14, 15, 15B, 126, 4A, in Section 33, Township 19, Range 31, Public Records of Seminole County, Florida to **North Beardall Avenue**; and

That portion of Beardall Avenue located in Sections 3 and 4, Township 20, Range 31, more particularly described as street name
