PROVIDING FOR CHANGING THE NAME OF WEST 13<sup>TH</sup> STREET (FROM US HIGHWAY 17-92 WESTERLY TO DIXIE WAY) TO HISTORIC GOLDSBORO BOULEVARD. THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING OF MAY 8, 2012.

WHEREAS, under the authority contained in Sections 336.05(1) and 336.05(2), Florida Statutes, the Board of County Commissioners may name and rename streets and roads; and

WHEREAS, the Board of County Commissioners has deemed it expedient to rename a segment of West 13<sup>th</sup> Street to Historic Goldsboro Boulevard; and

WHEREAS, the segment of West 13<sup>th</sup> Street to be renamed, consisting of Parcels 0000016 and 00000270 as shown on Exhibit A, attached hereto, is located within the City of Sanford and unincorporated Seminole County; and

WHEREAS, on January 9, 2012, the Sanford City Commission authorized the renaming of West 13<sup>th</sup> Street (from US Highway 17-92 westerly to Dixie Way) to Historic Goldsboro Boulevard with an effective date of June 1, 2012; and

WHEREAS, in support of the Sanford City Commission, renaming this street segment will help to eliminate confusion, facilitate improved emergency access, and ability of the public to locate streets and roads within Seminole County, Florida; and

WHEREAS, this change is consistent with overall County plans for street renaming, naming, addressing and the 911 system,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Seminole County, Florida:


Section 1. Effective June 1, 2012, the street is renamed as follows:

West 13<sup>th</sup> Street to Historic Goldsboro Boulevard (from US Highway 17-92 to Dixie Way); within Sections 35 and 35, Township 19, Range 30, Public Records of Seminole County, Florida.


