

RESOLUTION NO.: 1283

A RESOLUTION OF THE CITY OF ALTAMONTE SPRINGS, FLORIDA, CHANGING THE NAME OF ALBEMARLE ROAD (ALSO KNOWN AS ORCHARD TERRACE), LOCATED BETWEEN GATEWAY DRIVE AND MAITLAND BOULEVARD, BEING WITHIN THE CORPORATE LIMITS OF ALTAMONTE SPRINGS, FLORIDA, FROM "ALBEMARLE ROAD" (ALSO KNOWN AS "ORCHARD TERRACE") TO "INSPIRATION AVENUE;" PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a petition was filed by **ADVENTIST HEALTH SYSTEM SUNBELT HEALTHCARE CORP.**, to rename a portion of that certain right-of-way known as Albemarle Road (also known as Orchard Terrace), lying between Gateway Drive and Maitland Boulevard in the City of Altamonte Springs; and

WHEREAS, a portion of Albemarle Road was originally platted as Orchard Terrace by the 1926 Charlotte Heights Plat, recorded at Plat Book 5, Page 30, Public Records of Seminole County, Florida; and

WHEREAS, Albemarle Road lies in Altamonte Springs, Seminole County, Florida and contains 0.44 acres +/-, as is shown on **Exhibit "A"** attached hereto and incorporated herein by reference; and

WHEREAS, notice of public hearing before the City Commission of Altamonte Springs, Florida, was published on October 31, 2013, in the Orlando Sentinel, a newspaper of general circulation in Seminole County, Florida, which publication was at least thirty (30) days prior to the date stated therein for such public hearing; and

WHEREAS, notice of public hearing before the City Commission of Altamonte Springs, Florida, was further published by posting same at City Hall for a period of at least thirty (30) days prior to the date stated therein for such hearing; and

WHEREAS, a notice of public hearing before the City Commission of Altamonte Springs, Florida was sent to affected property owners informing same of the name change at least thirty (30) days prior to the date stated therein for such hearing; and

WHEREAS, the City Commission finds that the renaming of that certain street right-of-way will not operate to the detriment of the City or public.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALTAMONTE SPRINGS, FLORIDA, as follows:

1. That the above-described right-of-way lying within the City of Altamonte Springs, Florida, be and the same is hereby renamed from Albemarle Road (also known as Orchard Terrace) to Inspiration Avenue.
2. That all City maps and other documents shall be amended to reflect the change in the name of Albemarle Road (also known as Orchard Terrace) to Inspiration Avenue.
3. The City Clerk is hereby directed to notify all appropriate governmental agencies of the name change.
4. This Resolution shall become effective immediately upon its final passage and adoption.






