

RESOLUTION

of the

SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS

A RESOLUTION PROVIDING FOR RENAMING OF PENNSYLVANIA AVENUE TO SOUTH BRISSON AVENUE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, under the authority contained in Section 336.05, Florida Statutes (2013), the Seminole County Board of City Commissioners may name and rename streets and roads; and

WHEREAS, the Seminole County Board of County Commissioners has deemed it expedient to rename Pennsylvania Avenue to South Brisson Avenue for consistency throughout County records; and

WHEREAS, the road currently known as Pennsylvania Avenue to be renamed is wholly located within unincorporated Seminole County; and

WHEREAS, the road to be renamed was originally designated on an old plat as Pennsylvania Avenue, but the road has been unofficially known for decades as Brisson Avenue due in part to another road known as Brisson Avenue that is in line with and located directly north of the subject road; and

WHEREAS, renaming this road along with adding a directional South, will help to eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, Florida; and

WHEREAS, this change is consistent with overall County plans for street renaming, naming, addressing and the 911 system; and

WHEREAS, the attached Exhibit Map references the location of the proposed renamed South Brisson Avenue,

Section 1. Pennsylvania Avenue, as located within or abutting these plats recorded in the Public Records of Seminole County, is renamed as **SOUTH BRISSON AVENUE**:

"Plat of Palm Hammock Allotment," Plat Book 1, Page 104 depicting Pennsylvania Avenue as abutting the east boundary of Lots 30, 32, 36, 40, 44, 48, 52 and 56.

"Palmer's Subdivision," Plat Book 2, Page 41, specifically the road depicted as abutting the west boundary of Lots 1, 2, 3, 4, 5, 6 and 7.

All located in Section 17, Township 20, Range 31, and recorded in the Public Records of Seminole County, Florida.

Section 2. The road abutting the west boundary of the parcels having the following tax identification numbers as of the date of this resolution is also renamed as **SOUTH BRISSON AVENUE**.

All located in Section 17, Township 20, Range 31, in Seminole County, Florida.
