

**RESOLUTION**

of the

**SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS**

**A RESOLUTION PROVIDING FOR THE RENAMING OF THIRD COURT TO EAST 3RD COURT; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, under the authority contained in Sections 336.05, Florida Statutes (2013), and Chapter 90 of the Seminole County Land Development Code, the Seminole County Board of County Commissioners may name and rename streets and roads; and

**WHEREAS**, on July 9, 1991 the Seminole County Board of County Commissioners by Resolution 91-R-213 renamed Third Street to Third Court; and

**WHEREAS**, the County designates road names consisting of numbers in numeral format; and




**WHEREAS**, this street segment is located on the East side of County Road 419 and for consistency throughout County records, the Seminole County Board of County Commissioners has deemed it expedient to rename Third Court to East 3rd Court; and

**WHEREAS**, the Third Court street segment to be renamed is located between Jacobs Trail and easterly ending in the cul-de-sac as shown on Exhibit A attached hereto, and is wholly located within unincorporated Seminole County; and

**WHEREAS**, renaming this street with adding a direction East will help eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, Florida; and

**WHEREAS**, the change is consistent with overall County plans for street naming, addressing and 911 system; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:**

**Section 1.** The street segment of Third Court, formerly known as Third Street, as located within and depicted on these plats as Third Street, which plats were recorded in the Public Records of Seminole County, Florida, is renamed **EAST 3RD COURT**:

"Plat of Townsite of North Chuluota," Plat Book 2, Pages 54 through 58, recorded in the Public Records of Seminole County, Florida, depicting Third Street as abutting lots 1 and 16 through 19 in Block 24, lots 1 and 10 through 15 in Block 23, lots 2 through 5 in Block 29, and lots 1 through 7, Block 30,

"Replat of Part of Townsite North Chuluota," Plat Book 12, Pages 44 and 45, recorded in the Public Records of Seminole County, Florida, depicting Third Street as abutting lots 1 through 7 in Block 6, lots 8 through 14 in Block 7, lots 1 and 4 through 10 in Block 10, and lots 1 through 8, in Block 11.

All located in Section 21, Township 21 South, Range 32 East.


**Section 2.** This Resolution will become effective upon adoption by the Seminole County Board of County Commissioners.
