

RESOLUTION

of the

SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS

A RESOLUTION PROVIDING FOR THE RENAMING OF YORK COURT TO EAST YORK COURT (LONGWOOD 32779) AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, under the authority contained in Section 336.05, Florida Statutes (2014), and Chapter 90 of the Seminole County Land Development Code, the Seminole County Board of County Commissioners may name and rename streets and roads; and

WHEREAS, the Seminole County Board of County Commissioners has deemed it expedient to rename York Court to East York Court for consistency throughout County records; and

WHEREAS, York Court is a County maintained road; and

WHEREAS, currently there exists a West York Court, but York Court to the east does not contain a directional prefix; and

WHEREAS, the address ranges for each of the roads duplicate in both segments, therefore requiring directional prefixes to be used for York Court; and

WHEREAS, York Court is located within and surrounded by unincorporated County jurisdiction; and

WHEREAS, renaming the road will help eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, Florida; and

WHEREAS, the change is consistent with overall County plans for street naming, addressing and 911 system; and

WHEREAS, the attached Exhibit Map references the location of the road to be officially changed; and

WHEREAS, the street directional prefixes to be adopted by this Resolution are already being used on the Seminole County Property Appraiser map, in the Property Appraiser mailing addresses, in the Seminole County Geographic Information System (GIS) Address Map, in the Street Name database; by the United States Postal Service, and by the affected residents; and

WHEREAS, adoption of this Resolution will therefore not result in any address changes for the affected property owners; and

WHEREAS, adoption of this Resolution will officially correct the street name, since it was not recorded with a directional prefix.



NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:

Section 1. The portion of York Court, located on the East side of East Wekiva Trail, within and depicted on this plat recorded in the Public Records of Seminole County, Florida, is renamed to **EAST YORK COURT**:

"Wekiva Hunt Club, Fox Hunt Section 1" Plat Book 18, Page 83, depicting York Court as abutting Lots 182 through 185 and Tract "A."

Section 2. This Resolution will become effective upon adoption by the Seminole County Board of County Commissioners.


