

RESOLUTION

of the

SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS

A RESOLUTION PROVIDING FOR THE RENAMING OF ANTIETAM COURT TO WEST ANTIETAM COURT (WINTER PARK 32792); AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, under the authority contained in Section 336.05, Florida Statutes (2014), and Chapter 90 of the Seminole County Land Development Code, the Seminole County Board of County Commissioners may name and rename streets and roads; and

WHEREAS, the Seminole County Board of County Commissioners has deemed it expedient to rename Antietam Court to West Antietam Court for consistency throughout County records; and

WHEREAS, Antietam Court is a County maintained road; and

WHEREAS, currently there exists an East Antietam Court, but Antietam Court to the west does not contain a directional prefix; and

WHEREAS, the address ranges for each of the roads duplicate in both segments, therefore requiring a directional prefix to be used for Antietam Court; and

WHEREAS, Antietam Court is located within and is surrounded by unincorporated County jurisdiction; and

WHEREAS, renaming Antietam Court will help eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, Florida; and

WHEREAS, the change is consistent with overall County plans for street naming, addressing and 911 system; and

WHEREAS, the attached Exhibit Map references the location of the road to be officially changed; and

WHEREAS, the street directional prefix to be adopted by this Resolution is already being used on the Seminole County Property Appraiser map, in the Property Appraiser mailing addresses, in the Seminole County Geographic Information System (GIS) Address Map, in the Street Name database; by the United States Postal Service, and by the affected residents; and

WHEREAS, adoption of this Resolution will therefore not result in any address changes for the affected property owners; and

WHEREAS, adoption of this Resolution will officially correct the street name, since it was not recorded with a directional prefix.



NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:

Section 1. The portion of Antietam Court, located on the west side of Ferncrest Drive, within and depicted on these plats recorded in the Public Records of Seminole County, Florida, is renamed to **WEST ANTIETAM COURT:**

"Woodcrest Unit One" Plat Book 15, Page 55, depicting Antietam Court as abutting Lots 4 & 5; and

"Woodcrest Unit Two" Plat Book 15, Page 72, depicting Antietam Court as abutting Lots 24-31; and

Section 2. This Resolution will become effective upon adoption by the Seminole County Board of County Commissioners.


