

**RESOLUTION**

of the

**SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS**

**A RESOLUTION PROVIDING FOR THE DIVISION AND RENAMING OF FAITH TERRACE TO EAST FAITH TERRACE AND WEST FAITH TERRACE (32751); AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, under the authority contained in Section 336.05, Florida Statutes (2014), and Chapter 90 of the Seminole County Land Development Code, the Seminole County Board of County Commissioners may name and rename streets and roads; and

**WHEREAS**, the Seminole County Board of County Commissioners has deemed it necessary to rename Faith Terrace to East Faith Terrace and West Faith Terrace for consistency throughout County records; and

**WHEREAS**, Faith Terrace is a County maintained road wholly located within unincorporated Seminole County; and

**WHEREAS**, renaming Faith Terrace will help eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, Florida; and

**WHEREAS**, the change is consistent with overall County plans for street naming, addressing and 911 system; and

**WHEREAS**, the attached Exhibit Map references the location of the road to be officially changed; and

**WHEREAS**, the street directional prefixes to be adopted by this Resolution are already being used in the Seminole County Property Appraiser mailing addresses, in the Seminole

County Geographic Information System (GIS) Address Map, and in the Street Name database;  
and

**WHEREAS**, adoption of this Resolution will officially correct the street names, since they were not recorded with a directional prefix.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:**

**Section 1.** The portion of Faith Terrace, located on the east side of Maitland Avenue, within and depicted on this plat recorded in the Public Records of Seminole County, Florida, is renamed to **EAST FAITH TERRACE:**

"Northwood Heights" Plat Book 10, Page 28.

**Section 2.** The portion of Faith Terrace, located on the west side of Maitland Avenue, within and depicted on these plats recorded in the Public Records of Seminole County, Florida, is renamed to **WEST FAITH TERRACE:**

"Oakland Shores," Plat Book 10, Pages 3 and 4, depicting Faith Terrace as abutting Lots 1 and 16 through 24, in Block "B" and Lots 2 through 10 in Block "C" and Lots 3 through 8, in Block "E."

"Oakland Shores First Addition," Plat Book 10, Page 59, depicting Faith Terrace as abutting Lots 11 through 13 in Block "F" and Lots 13 through 15 in Block "G."


**Section 3.** This Resolution will become effective upon adoption by the Seminole County Board of County Commissioners.
