SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS

A RESOLUTION PROVIDING FOR A RENAMING OF 2nd AVENUE TO DIESEL LANE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, under the authority contained in Section 336.05, Florida Statutes (2016), and Chapter 90 of the Seminole County Land Development Code, the Seminole County Board of County Commissioners may name and rename streets and roads; and

WHEREAS, the Seminole County Board of County Commissioners has deemed it expedient to rename 2nd Avenue to Diesel Lane for consistency throughout County records; and

WHEREAS, 2nd Avenue is located within unincorporated Seminole County jurisdiction between Lincoln Street and Main Street in Sanford, Florida 32771; and

WHEREAS, the County has readdressed the only affected property owner from 2nd Avenue to Diesel Lane on September 21, 2006; and

WHEREAS, a review of Google Street indicates the street sign displays Diesel Lane; and

WHEREAS, the GIS Situs Address Layer and Street Centerline name currently is Diesel Lane; and

WHEREAS, this segment of roadway is not depicted on any recorded plat, but it is depicted on the attached map;

WHEREAS, adoption of this Resolution will therefore not result in any address changes for the affected property owners; and

WHEREAS, adoption of this Resolution will officially correct the street name in County records; and


Section 1. The portion of 2nd Avenue, as located within and depicted on the attached map, abutting parcels:
