A RESOLUTION PROVIDING FOR THE RENAMING OF HOLLEY HILL TO HOLLY HILL; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, under the authority contained in Sections 336.05, Florida Statutes (2015), and Chapter 90 of the Seminole County Land Development Code (2015), the Seminole County Board of County Commissioners may name and rename streets and roads; and

WHEREAS, the Seminole County Board of County Commissioners has deemed it expedient to rename "Holley Hill" to "Holly Hill" for consistency throughout County records; and

WHEREAS, Holley Hill is located within and is surrounded by unincorporated County jurisdiction; and

WHEREAS, renaming this street will help eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, Florida; and

WHEREAS, the change is consistent with overall County plans for street naming, addressing and 911 system; and

WHEREAS, the attached Exhibit Map references the location of the road to be officially changed; and


WHEREAS, the property owners have notified the County they are using the street name as "Holly Hill;" and

Information System (GIS) Map Street Centerline Layer, the Situs Address Layer and the Master Street Address Guide (MSAG) indicate the street name as "Holley Hill"; and

WHEREAS, the United States Postal Service and street sign indicate "Holly Hill"; and

WHEREAS, the Holley Hill street segment to be renamed is located adjacent to North Stone Gate as shown on the attached Exhibit Map, and is wholly located within unincorporated Seminole County; and

WHEREAS, adoption of this Resolution will officially correct the street name, as the plat was recorded with an "e" in Holley; and



Section 1. **HOLLEY HILL**, as located within and depicted on the following plat recorded in the Public Records of Seminole County, Florida, is renamed to **HOLLY HILL**:


"Ravensbrook First Addition", Plat Book 16, Page 31, depicting Holley Hill as abutting lots 46 through 49.
