

THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING OF DECEMBER 11, 1990.

WHEREAS, under the authority contained in Section 336.05(1) and 336.05(2), Florida Statutes, the Board of County Commissioners may name and rename streets and roads; and

WHEREAS, a request has been received to name an unnamed street located in Section 4, Township 21, Range 30; deeded as a public road in Deed Book 72, Page 104 Public Records of Seminole County and described as follows:

Beginning 662.13 feet West and 305 feet South of the Northeast corner of Lot 1 in the plat of Irendale, Seminole County, Florida, of record in Plat Book 6, Page 95, Public Records of Seminole County, Florida; thence run West 442 feet; thence South 504 feet more or less to a point 50 feet measured Northerly at right angles from the South line of said Lot 1; thence South 83°13' West parallel with and 50 feet from the South line of said Lot 1 to the Easterly side of State Road No. 3; thence Southerly along the East side of State Road No. 3, to the Southwest corner of said Lot 1; thence North 83°13' East along the South line of said Lot 1 to a point South of beginning; thence North 500 feet more or less to beginning; Less the East 50 feet and a strip of land 50 feet in width adjacent to and on the Northerly side of the Southern boundary of said Lot 1 which is to be used as a public road. Containing 4.3 acres more or less of land and water.

WHEREAS, naming this unnamed street is consistent with overall County plans for street naming, addressing and the E-911 system.

NOW, THEREFORE, BE IT RESOLVED, that effective December 11, 1990, the unnamed street described herein that is known as Lake Irene Road be named:

LAKE IRENE ROAD
