

RESOLUTION NO. 565

A RESOLUTION OF THE CITY OF LAKE MARY, FLORIDA, REPEALING RESOLUTION NO. 563 WHICH RENAMED A PORTION OF FLORA CREEK EAST OF TIMACUAN BOULEVARD TO MAYA STREET; RENAMING MUSCOSAW COURT EAST OF TIMACUAN BOULEVARD TO MAYA STREET; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Commission of the City of Lake Mary, Florida, is concerned with the safety of its citizens; and

WHEREAS, conflicting street names for the same right-of-way may cause delays in response to citizens' calls for assistance and danger to its citizens by a delayed response from fire or police; and

WHEREAS, on December 19, 1996, the City Commission adopted Resolution No. 563 renaming a portion of Flora Creek Court east of Timacuan Boulevard to Maya Street; and

WHEREAS, said Resolution was in error and the Commission is desirous of repealing Resolution No. 563.

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of Lake Mary, Florida, that:

1. Resolution No. 563 is hereby repealed.
2. Muscosaw Court east of Timacuan Boulevard in Timacuan is hereby renamed Maya Street.

This Resolution shall take effect upon adoption.
