- Park Participation numbers/discussion Mr. Goff expressed concern that he had been
 requesting more detailed park data and participation numbers. Julia brought to the

 the amount of detail and confirmation that the numbers are as accurate as possible due

- Bryan Nipe/Update on Winwood Park Julia related that Bryan has confirmed that the CDBG will be available in October and that Winwood Park is a good candidate for receiving the funds. More details will be made available as to the final grant submittal closer to the end of summer. Julia also related that Bryan and staff had met with the Boys and Girls Club and adjacent church officials. Both expressed support regarding park renovations and usage.
- School Partnership Mr. Nicholas reported that he and Julia had both visited Idyllwild Elementary School and Milwee MS with positive results from school administrators. Julia will be speaking with the SAC committee on Thursday, Feb. 4th at Idyllwild to confirm their interest and establish direction. Julia will also work with Milwee MS Asst. Principal Barry Tacktill to confirm what programs and space needs will suit both agencies. Julia will work towards preparing a draft budget and schedule based on the schools interests and our Department's needs. Conversation ensued about the school maintenance contract budget. Julia will research potential impacts.
- Youth Sports League Standards This item will be brought back up to the committee once appropriate revisions have been made. Julia will work with Tom Boyko to refine the revisions to the existing document.
