## **OLD BUSINESS:**

## **Bruce Parcel**

The group discussed the Bruce parcel site visit, ranking and criteria and made the following recommendation.

The ±20-acre Bruce property was assessed by the Natural Lands Subcommittee on Wednesday, September 22, 2010. Jim Duby, Sherry Williams, and Bryan Nipe with the Leisure Services Department also attended. The site consists of 3 platted parcels with residential zoning. The site is bordered to the north by Lake Jesup, to the east and west by private residences, and to the south by Black Hammock Rd. The site is approximately 60% upland and 40% forested wetland. The upland portion of the property is currently an active orange grove. The forested wetland community onsite is contiguous with Lake Jesup and consists of bald cypress, sweet gum, pop ash, and other wetland hardwood species. The landowner is currently asking approximately \$800,000 for the 35-acre parcel.

Based on the site review and the Site Evaluation Criteria & Ranking Procedures score, the Natural Lands subcommittee does not recommend the site for purchase at this time. The site is currently zoned A-3. It does not contain rare communities or species. 60% of the property is an active orange grove, which is not undeveloped, desirable land.

## **Wilderness Area Improvements**

Bryan Nipe provided an update on the site enhancement projects stating that staff is still in the process of gathering information. Bryan stated the next step was for him and Joe Abel to discuss this with the County

- User Survey develop user survey for natural lands

#### 2011 - 2012

- County-wide analysis of greenway/connectivity for future land acquisition
- Environmental Advocacy each subcommittee member to organize and help setup natural lands displays (posters, pamphlets, etc.) at libraries, active

recreation parks, trail heads, etc.
