Ms. Thompson will make sure that Mr. Nicholas is provided with a copy of the Inventory and Analysis document that was handed out to LSAC members at the December meeting.

 - Mr. Boyko reported that the Seminole County Charter will be reviewed in 2012 and that he had sat on the last review committee and could be appointed again. This is done through the Board of County Commissioners.
 - Mr. Boyko and Mr. Nicholas both asked if there was any update on Jetta Point Park and Soldiers Creek Park. Julia reported that she had not heard of anything new regarding Jetta but thought that the Board would bring it up as

an item soon as budgets were being developed for the upcoming fiscal year. Mr. Boyko reported that he had visited Soldiers Creek Park to view the conditions of the complex, restrooms and concession area and had even taken pictures. He reported that the restrooms did not appear to be in poor condition but did comment on the odor.

Ms. Thompson reported that coming up on Saturday March 5th was an opportunity for the committee to volunteer for Tennis Day in Seminole County. This event will be held at the Red Bug, Sanlando and Sylvan Lake Parks. Julia will provide additional details at the next meeting.
