Sub-Committee Reports

Natural Lands Subcommittee

- o Mr. Brandenburg advised that the Committee met this morning. They evaluated the Villeneuve parcel. Trish Walden made a motion that the Committee to recommend that staff approach the BCC about purchasing the Villeneuve parcel next to the Lake Harney Wilderness Area. Mike Williams seconded the motion. Discussion followed. The motion passed unanimously.
- The Subcommittee also further reviewed their goals.

· Trails, Blueways and Bike Paths Subcommittee

- Mr. Williams reported that they met with Public Works. Public Works staff proposal for the third generation sales tax has \$10 million budgeted for improvements to the trails that are not yet BCC approved.
- It was suggested that rather than the Subcommittee take on adopting a trail perhaps the entire Committee could adopt a trail. The question was asked, "What does it mean to adopt a trail?" The Subcommittee will investigate further and report back.
- Mr. Williams informed the Committee that the Trails Subcommittee is changing their meeting date to the second Wednesday of the month. The next meeting will be 8:00 a.m. on March 9th, at the City of Casselberry's Secret Lake Park and they will be touring Lake Triplet. All are welcome.

Parks & Recreation Subcommittee

- Mr. Boyko reported that there will be a partnership with Milwee Middle School this summer. It is a pilot program. They are still pursuing a partnership with Idlewilde Elementary.
- The improvements to Winwood Park are 75% complete and 100% completion is expected by the end of March.
- Goals were further reviewed.
